5. Phone Call with Building Superintendent from Eugene, OR to Hear of Their

**Experience with a Similar Project** – J. Collins placed the phone call and explained what is happening in our district with the water. Building Supt. from Oregon stated that they did an RFQ for a design build and a "not to exceed amount". They invited 6 contractors to the RFQ and 3 or 4 showed up. Building Supt. from Oregon noted that they were able to complete their project in about 3 weeks.

T. Van Tasel questioned if anyone in their district had prior experience with this type of situation. Building Supt. from Oregon indicated that this was not the first school they had to repipe, and that they had a similar project in the middle school. However, Page Elementary was the first "whole school" project. T. Van Tasel questioned where the pipes were located in the school. Building Supt. from Oregon stated that the existing pipes were underground and there is a tunnel to crawl through. In addition, their school is wood structure and there are essentially wood panels for the walls that could be removed for easy access.

The Committee thanked Building Supt. from Oregon for his time.
